**Q1. Answer all of the following (in not more than 200 words each) : 5×5=25**

- (a) Describe the economic conditions of Later Vedic Period. How was it different from Rig Vedic life ?
- (b) Discuss the similarities and differences between the basic tenets of Buddhism and Jainism.
- (c) Trace the evolution of Temple architecture in South India.
- (d) How did the Bhakti Movement contribute to the growth of regional languages ?
- (e) Highlight the role of Peoples' movement towards the integration of Princely States into the Indian Union.

**Q2. Answer all of the following (in not more than 200 words each) : 5×5=25**

- (a) "Climate change is likely to adversely affect certain countries dependent on agriculture." Examine this statement citing relevant examples.
- (b) Many countries prefer coal rather than solar or wind energy as a source of fuel. Why ?
- (c) "Air pollution and water shortages are among the problems faced by urban centres across the globe." Examine this statement.
- (d) What factors influence the location of industries in India today ?
- (e) "Degradation of forest resources and wildlife is a fallout of agriculture and urbanization." Assess this statement giving examples from India.

**Q3. Answer all of the following (in not more than 200 words each) : 5×5=25**

- (a) Critically examine Indian Agriculture Acts of 2020.
- (b) "Privatization of Public Sector Banks is fraught with huge risk." Elucidate.
- (c) Do you believe that Aatmanirbhar Bharat Abhiyaan, 2020 will be able to combat the COVID-19 crisis of the Indian economy? Justify your answer.
- (d) Analyse the recommendations of the Narasimham Committee Report I and II in controlling Non-Performing Assets (NPAs) of the banking sector in India.
- (e) Discuss the roles and responsibilities of the Anganwadi workers and helpers under Integrated Child Development Services Scheme (ICDS).

**Q4. Answer all of the following (in not more than 200 words each) : 5×5=25**

- (a) "The Indian Constitution is a living document." Discuss.
- (b) Critically examine the financial emergency powers of the President and their effects.
- (c) "The Rajya Sabha has certain special powers vis-à-vis the Lok Sabha that adds to its prestige." Comment.
- (d) Compare the writ jurisdictions of the Supreme Court and the High Court.
- (e) "The Indian Government's response to the COVID-19 pandemic has shifted the federal balance in its favour." Illustrate with suitable examples.
